WAM CAPITAL JANUARY 2007 INVESTMENT UPDATE & NTA

Since inception in August 1999 WAM Capital Ltd (WAM) has outperformed the overall sharemarket. WAM's portfolio (before all fees, costs, taxes and dividend) has increased by 497.0% compared to a 161.2% increase in the All Ordinaries Accumulation Index.

- In January WAM's gross portfolio (before all fees, costs and taxes) increased by 3.80%, while the All Ordinaries Accumulation Index rose by 2.01%.
- The gross portfolio has increased 26.9% for the 7 months to 31 January 2007.
- The NTA before tax was 199.19* cents a share, as at 31 January 2007.
- The NTA after tax was 179.06* cents a share, as at 31 January 2007.

MARKET OUTLOOK

The Australian sharemarket entered the new calendar year in strong fashion by rising 2.01% in January. The ongoing positive sentiment has been stoked by the belief the Reserve Bank will not have to raise rates in 2007. Can the sharemarket rally, now 4 years old, continue? It is very difficult to see the Australian market turning down given the positive sentiment and inflow of superannuation money. However we remain cautious given valuations, especially in industrial stocks, are stretched.

DIVIDEND

On the 6th February the Directors declared an interim dividend of 8.0 cents a share fully franked payable on the 27 April 2007. The shares will trade ex dividend on 16 April 2007.

Option holders who exercise their options by the 13 April 2007 will receive the interim dividend of 8.0 cents a share.

OPTIONS ISSUE

On 24th October 2006, the Directors of WAM Capital Limited announced a 1 for 1 bonus issue of options to its shareholders. The options were allotted to shareholders on 1st December 2006 and have been issued at no cost to shareholders. The options have an exercise price of \$1.80 per option and can be exercised any time up until the expiry date of 17 December 2007. As at the 8th February 445,566 options have been exercised for a total consideration of \$802,019 with a remaining balance of outstanding options being 67,765,205.

PORTFOLIO STRUCTURE & STRATEGY

As at 31 January 2007, listed securities made up approximately 91% of the portfolio, while fixed interest and cash made up the remaining 9%. We continue to focus on companies with strong earnings per share growth, trading on attractive earnings multiples, and are well positioned in growth industries and have proven management. We continue to research heavily to find companies that meet this profile.
