WAM CAPITAL AUGUST 2006 INVESTMENT UPDATE & NTA

Since inception in August 1999 WAM Capital Ltd (WAM) has outperformed the overall sharemarket. WAM's portfolio (before all fees, costs, taxes and dividend) has increased by 388.6% compared to a 127.2% increase in the All Ordinaries Accumulation Index.

- In August WAM's gross portfolio (before all fees, costs and taxes) increased by 3.44%, while the All Ordinaries Accumulation Index rose by 3.18%.
- The gross portfolio has increased 3.88% for the 2 months to 31 August 2006.
- The NTA before tax was 172.79 cents a share, as at 31 August 2006.
- The NTA after tax was 161.34 cents a share, as at 31 August 2006.

The above figures are before the payment of a final dividend of 7.0 cents a share fully franked, payable on the 27 October 2006.

WAM is an investment company whose mission is to provide superior returns to its investors over the medium to long term. WAM is managed by Wilson Asset Management (International) Pty Limited.

MARKET OUTLOOK

The Australian sharemarket continues to be volatile. While August was a strong month on the back of a solid profit reporting season, investor nervousness has returned in September. Around the world investors are uncertain about the global growth outlook. This uncertainty has resulted in a sell off in resource stocks. Given this environment, we remain cautious in the short term.

DIVIDEND

The final dividend of 7.0 cents a share fully franked, will bring the full year dividend to 14.0 cents a share. The shares will trade ex dividend on 16 October 2006 with payment on 27 October 2006.

PORTFOLIO STRUCTURE & STRATEGY

As at 31 August 2006, listed securities made up approximately 79% of the portfolio, while fixed interest and cash made up the remaining 21%. We continue to focus on companies with strong earnings per share growth, trading on attractive earnings multiples, and are well positioned in growth industries and have proven management. We continue to research heavily to find companies that meet this profile.
