WAM CAPITAL NOVEMBER 2005 INVESTMENT UPDATE & NTA

Since inception in August 1999 WAM Capital Ltd (WAM) has outperformed the overall sharemarket. WAM's portfolio (before all fees, costs, taxes and dividend) has increased by 315.3% compared to a 98.8% increase in the All Ordinaries Accumulation Index.

- In November WAM's portfolio (before all fees, costs and taxes) increased by 3.0%, while the All Ordinaries Accumulation Index increased by 4.4%.
- The NTA before tax was 158.53 cents a share, as at 30 November 2005.
- The NTA after tax was 149.21 cents a share, as at 30 November 2005.

The above figures are after the payment of a final dividend of 6.0 cents a share fully franked.

WAM is an investment company whose mission is to provide superior returns to its investors over the medium to long term. WAM is managed by Wilson Asset Management (International) Pty Limited.

MARKET OUTLOOK

The Australian sharemarket rose sharply in November after a poor October. The market is now close to record highs and while the Christmas/New Year period is traditionally a strong period for equities, the Australian market is relatively expensive compared to other sharemarkets. We are also concerned about the recent rebound in the oil price which earlier in the year dampened consumer spending and sparked inflationary concerns. As a result we remain cautious.

DIVIDEND

The final dividend of 6.0 cents a share fully franked brought the full year dividend to 12.0 cents a share. The shares traded ex dividend from 4 October 2005, with payment on 17 October 2005.

PORTFOLIO STRUCTURE & STRATEGY

As at 30 November 2005, equities made up approximately 86% of the portfolio, while fixed interest and cash made up the remaining 14%. We continue to focus on companies with strong earnings per share growth, trading on attractive earnings multiples, and are well positioned in growth industries and have proven management. We continue to research heavily to find companies that meet this profile.
