Since inception in August 1999 WAM Capital Ltd (WAM) has outperformed the overall sharemarket. WAM's portfolio (before all fees, costs, taxes and dividend) has increased by 124.8% compared to a 16.2% increase in the All Ordinaries Accumulation Index.

- In June WAM's portfolio (before all fees, costs and taxes) decreased by 2.2% while the All Ordinaries Accumulation Index fell by 4.4%.
- Since 30th June 2001 WAM's gross portfolio has increased by 32.7% against a 4.5% fall by the All Ordinaries Accumulation Index.
- The NTA before all taxes was 137.6c a share, as at 30th June.
- The NTA after all taxes was 128.2c a share, as at 30th June.

MARKET OUTLOOK

The sharemarket's near term performance will continue to be undermined by the negative sentiment currently gripping investors. We believe this situation is creating some excellent buying opportunities.

PORTFOLIO STRUCTURE & STRATEGY

As at 30th June 2002 equities made up approximately 66% of the portfolio, while fixed interest and cash made up the remaining 34%. We continue to focus on companies with strong earnings per share growth, trading on attractive earnings multiples, that are well positioned in growth industries and have proven management. We continue to research heavily to find companies that meet this profile.

DIVIDENDS

The directors declared an interim dividend of 4 cents a share fully franked. This was paid on the 19th April and went ex-dividend on the 5th April 2002.
