## **WAM CAPITAL NOVEMBER 2003** **INVESTMENT UPDATE & NTA**

Since inception in August 1999 WAM Capital Ltd (WAM) has outperformed the overall sharemarket. WAM's portfolio (before all fees, costs, taxes and dividend) has increased by 196.7 %\* compared to a 24.8% increase in the All Ordinaries Accumulation Index.

- In November WAM's portfolio (before all fees, costs and taxes) decreased by 0.7% while the All Ordinaries Accumulation Index fell by 2.1%.
- The NTA before tax was 148.2c\* a share, as at 30<sup>th</sup> November.
- The NTA after tax was 137.2c \* a share, as at 30<sup>th</sup> November.

### **MARKET OUTLOOK**

After a buoyant year the Australian equity market has entered a consolidation phase. The direction of the equity market will depend on how high official interest rates rise and how strong company earnings grow. If earnings growth is stronger than expected and the interest rate environment is benign, equity prices will rise in the New Year.

### **PORTFOLIO STRUCTURE & STRATEGY**

As at 30<sup>th</sup> November 2003 equities made up approximately 79% of the portfolio, while fixed interest, cash, and listed debt made up the remaining 21%. We continue to focus on companies with strong earnings per share growth, trading on attractive earnings multiples, that are well positioned in growth industries and have proven management. We continue to research heavily to find companies that meet this profile.
