WAM CAPITAL APRIL 2004 INVESTMENT UPDATE & NTA

Since inception in August 1999 WAM Capital Ltd (WAM) has outperformed the overall sharemarket. WAM's portfolio (before all fees, costs, taxes and dividend) has increased by 219.6% compared to a 34.7% increase in the All Ordinaries Accumulation Index.

- Gross portfolio has risen 27.4% in the ten months to 30 April 2004.
- In April WAM's portfolio (before all fees, costs and taxes) decreased by 1.28% while the All Ordinaries Accumulation Index decreased by 0.13%.
- The NTA before tax was 151.1c* a share, as at 30 April 2004.
- The NTA after tax was 138.8c* a share, as at 30 April 2004.

WAM is an investment company whose mission is to provide superior returns to its investors over the medium to long term. WAM is managed by Wilson Asset Management (International) Pty Limited.

DIVIDEND

An interim dividend of 5.0 cents per share fully franked was paid to shareholders on 27 April 2004. This was a 20% increase on the previous corresponding period. The shares were quoted ex dividend on 13 April 2004.

MARKET OUTLOOK

In recent weeks the investment community has switched its primary focus from a recovery in corporate earnings to rising interest rates. This is expected to provide a handbreak on equity prices. In the medium term the investment community will become more comfortable with higher interest rates and the outlook for equities should improve.

PORTFOLIO STRUCTURE & STRATEGY

As at 30 April 2004 equities made up approximately 67% of the portfolio, while fixed interest, cash, and listed debt made up the remaining 33%. We continue to focus on companies with strong earnings per share growth, trading on attractive earnings multiples, that are well positioned in growth industries and have proven management. We continue to research heavily to find companies that meet this profile.
