MARKET OUTLOOK

The All Ordinaries Index hit a fresh high on 1 November 2007. Since then, the index has fallen approximately 11%. The catalyst for the fall has been the significant slow down in the US economy and subsequent revisions for world growth. While the Australian economy remains robust, with strong housing and retail numbers in the lead up to Christmas, we are concerned about the prospects for Australian company earnings as the global slowdown bites. As a result, we have raised our cash positions. We expect the Australian market will find it difficult to reach new highs in the near term and expect ongoing volatility. These types of shakeouts normally present selective stock buying opportunities and we expect this time will be no different.

DIVIDEND

The final dividend for the 2007 year was 2.75 cents a share fully franked paid on 26 October 2007. The final dividend carried with it an attributable LIC capital gain of 2.0 cents per share which will enable some shareholders to claim a tax deduction.
