DIVIDENDS

The interim dividend of 2.5 cents a share fully franked was paid on 26 May 2006.

SHARE BUY BACK

The board is focused on maximising returns to shareholders and this will from time to time involve active capital management. The board views an on market share buy back as being in line with this aim as it will add value to the remaining shares on issue and increase NTA per share.

On the 1 May 2006 the board commenced another buyback of up to 10% of issued capital being equivalent to 13,272,776 shares. As at the 30 June 2006 a total of 7,815,482 shares have been bought back for a total consideration of \$7,582,376.

MARKET OUTLOOK

The Australian sharemarket has undertaken a solid rally following a 10% slide during May and early June. The sudden dip in share prices was the result of an overheated resources sector and uncertainty about US interest rates. The resources sector, which suffered a 25% fall, has started to climb again. However we believe that the sector will be highly volatile in the near term. We also believe the overall sharemarket will be volatile until such time as the US Federal Reserve stops raising official interest rates.
