

# Annual General Meeting Chairman’s Address

20 November 2018

## Introduction and welcome

Good afternoon and welcome to the 20<sup>th</sup> WAM Capital Limited Annual General Meeting (AGM). I would firstly like to acknowledge the Gadigal people of the Eora nation and pay my respects to their Elders past and present. I would also like to welcome all our shareholders – thank you for joining us and for your continued support of WAM Capital.

I am Geoffrey James Wilson, Chairman of the Board of Directors. I am joined today by my fellow Board members, Katherine Anne Thorley, Christopher David Stott, Dr Philippa Ann Ryan, Lindsay Robert Mann and James Miller Chirnside. Chris Chandran, a representative from our auditor Pitcher Partners, will be available to address any questions relating to the Company’s financial statements.

## Solid investment portfolio performance

WAM Capital has consistently applied its proven investment philosophy to achieve sound, risk-adjusted portfolio returns derived from investments in undervalued growth companies. The portfolio has returned 17.5% per annum since inception in August 1999, outperforming the S&P/ASX All Ordinaries Accumulation Index by 9.0%, while holding an average of 33.9% in cash.

The investment portfolio continued to deliver solid performance during the 2018 financial year. The investment portfolio increased 15.0%, outperforming the S&P/ASX All Ordinaries Accumulation Index which rose 13.7%. This risk-adjusted investment portfolio performance was achieved with an average cash weighting of 29.5%, with the investment portfolio recording a standard deviation of 4.4% against the market’s 7.1% for the year. The return on the equity portion of our portfolio was 20.4% and the return on the cash portion of the portfolio was 2.0% for the year.

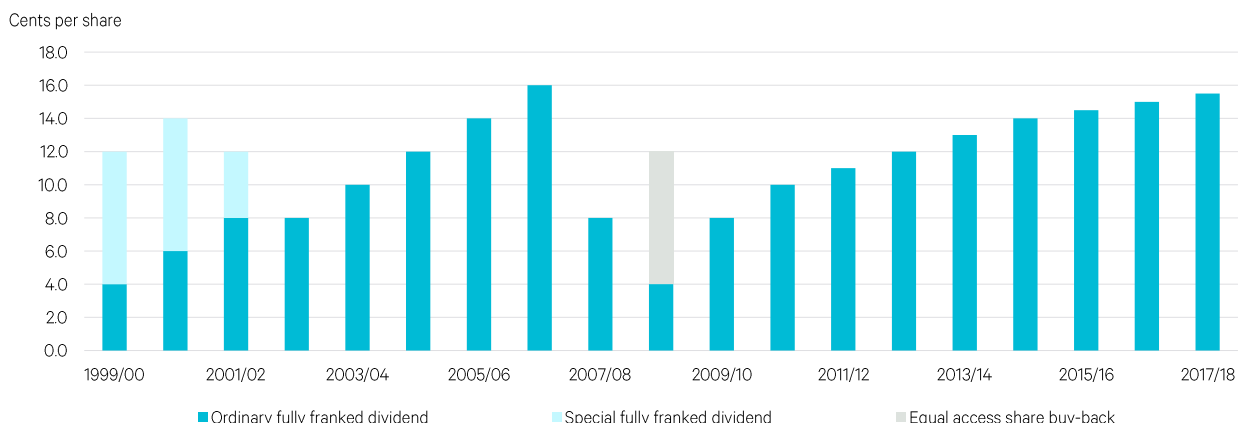
## Total shareholder return and share price premium to NTA

The total shareholder return (TSR) for WAM Capital for the year to 30 June 2018 was 6.1%. The TSR was largely driven by WAM Capital’s investment portfolio performance of 15.0%, being offset by the reduction in the share price’s premium to net tangible asset (NTA). On 19 November 2018, the share price premium to NTA was 14.6%. Throughout its 20-year history, the Company’s share price has traded at both premiums and discounts to its NTA.

## Continued fully franked dividend growth

The Board continued to enhance shareholder returns through the payment of fully franked dividends in FY2018. The fully franked full year dividend increased to 15.5 cents per share. Since inception, the Company has paid \$2.15 per share in fully franked dividends to shareholders. As at 31 October 2018, the profits reserve was 15.53 cents per share after the fully franked 7.75 cents per share final dividend payable on 26 November 2018.

## Strong financial results and growth in assets

In 2018, the Company achieved continued growth increasing shareholders equity by 9.0% to \$1,323.8 million and total shareholder numbers by 13.4% to 30,998. The Company recorded a pre-tax profit of \$166.9 million and paid tax of \$32.0 million and dividends of \$82.1 million. This growth was achieved through the strong absolute performance of the investment portfolio and the capital management initiatives.

During the financial year, WAM Capital raised \$66.2 million through dividend reinvestment plan shortfall placements to wholesale investors. The price the capital was raised at was a premium to the NTA backing at the time, which provided shareholders with a \$10.7 million benefit. This benefit offset more than 70% of the Company's expenses and fees for the year to 30 June 2018.

In October 2018, WAM Capital succeeded with its takeover offer for Wealth Defender Equities Limited. The bid resulted in the issuance of shares at a premium to WAM Capital's pre-tax NTA.

As the Company's capital base increases, its on-market liquidity increases and its relevance in the market grows. All of these factors improve the prospect of broker and research coverage and can drive additional interest from financial planners.

## Equity market outlook

Over the last decade, central banks have pumped an unprecedented level of liquidity into the economic system, lowering interest rates to record levels and driving asset valuations to extremes.

The recent stock market rout in October has wiped out the 2018 calendar year gains in the US, while China's equity market has fallen by more than 25% from its peak earlier this year and Australia has entered a technical correction. We believe we are in the final stages of the longest US bull market in history. What concerns us the most is that all bear markets are extremely painful.

Fortunately, we have worked through a number of bear markets before and as investors we are excited about the opportunities that will present themselves. During these periods patience is the key.

We expect the negative effects of the bear market will be significantly worse if Labor wins office. We believe Shorten and Bowen's plans will have dramatic implications for the equity and property markets, resulting in the first economic recession in Australia for 27 years.

Given our cautious outlook, we have steadily increased our listed investment companies' (LIC) cash weightings to withstand increasing volatility and ensure necessary liquidity in our portfolios, which unfortunately will not make us immune to the effects of an equity bear market. WAM Capital's cash weighting was 38.0% at 19 November 2018.

## Company outlook

WAM Capital entered the 2019 financial year with a conservative balance sheet, a high cash weighting, no debt and a flexible and proven investment approach with the patience and expertise of an experienced investment team. The Company will continue to seek opportunities irrespective of market conditions, having achieved outperformance through various market cycles.

## Board changes

In April 2018, Matthew Kidman resigned from the Board of Directors. The Board would like to thank Matthew for his contribution to WAM Capital as a founding Director, guiding the Company from its listing in 1999. We will all miss Matthew's valued contributions to the Board.

During the year, the Board welcomed Dr Philippa Ryan as a Director. Dr Ryan is a highly experienced legal academic with exceptional experience in commercial law, corporate governance, finance and technology.

## Public policy and advocacy – defending the current dividend imputation system

Wilson Asset Management continues to engage in public policy discussions and advocates on behalf of all shareholders regarding issues of importance. Early in the 2018 calendar year, the Federal Opposition announced a policy to remove the mechanism for the Australian Taxation Office to refund tax paid on dividend income. We believe it is unfair to change the rules on self-funded retirees, older workers and low income earners. On 11 May 2018, Wilson Asset Management launched a petition to maintain the current dividend imputation system, with almost 30,000 signatures collected to date.

We lodged a submission to the House of Representatives Standing Committee on Economics Inquiry into the implications of removing refundable franking credits, which detailed the negative economic and social impacts of this proposed policy and the positive aspects of the current franking credits system. We will continue to monitor the proposed policy changes and engage in the public debate.
